Minimum environmental and social requirement for biofuels imported from non-EU countries or produced from agricultural raw materials originating from non-EU countries

- 1. Minimum environmental and social requirements for biofuels imported from non-EU countries or produced from agricultural raw materials originating from non-EU countries shall be deemed as fulfilled if, in the country of origin, the biofuels or raw materials are certified and the following ILO conventions applied:
- 1) Convention on Forced or Compulsory Labor (Law on the project Convention on Forced or Compulsory Labor, "Official Gazette of the Kingdom of Yugoslavia", No. 297-CXI/32),
- 2) Convention on Freedom of Association and Protection of the Right to Organize (Regulation on ratification of the ILO Convention no. 87 on freedom of association and protection of the right to organize, "Official Gazette of FNRY International treaties", no. 8/58),
- 3) Convention on the Right to Organize and Collective Bargaining (Regulation on ratification of the ILO Convention no. 98, on the right to organize and collective bargaining, "Official Gazette of FNRY Addendum", no. 11/58),
- 4) Convention on equal remuneration for men and women workers for work of equal value (Decree on Ratification of Convention on equal remuneration for men and women workers for work of equal value, "Official Gazette of the Presidium of the National Assembly of the FPRY", no. 12/52),
- 5) Convention on Abolition of Forced Labor (Law on ratification of the ILO Convention no. 105 Abolition of Forced Labor, "Official Gazette of FNRY International treaties", no. 13/02),
- 6) Convention on discrimination in terms of employment and occupation (Regulation on ratification of the ILO convention 111 (employment and occupation), "Official Gazette of FNRY International treaties", no. 3/61),
- 7) Convention no. 138 on minimum age for admission to employment (Law on ratification of ILO Convention no. 138 on minimum age for admission to employment, "Official Gazette of SFRY International treaties", no. 14/82).
- 2. In addition to the conventions of the International Labor Organization referred to in paragraph 1 of this Annex, the following international acts must be confirmed and applied in the country of origin of the biofuels i.e. raw materials, that is not a EU-member state:
- 1) Cartagena Protocol on Biological Protection to the Convention on Biological Diversity (Law on Ratification of the Cartagena Protocol on Biological Protection to the Convention on Biological Diversity, with Annexes, "Official Gazette of SCG International Treaties", No. 16/05);
- 2) Convention on International Trade in Endangered Species of Wild Fauna and Flora (Law on Ratification of the Convention on International Trade in Endangered Species of Wild Fauna and Flora, "Official Gazette of the FRY International Treaties", No. 11/01).
