Bids with all the evidence are to be submitted to the address of the contracting authority: Ministry of Mining and Energy- Administration for energy products, Kralja Milana 36, Belgrade, stating:” **Bid for public procurement - Call option agreement for oil products (tickets)- PP No. 04/17- DO NOT OPEN** “. The name, address and telephone number of bidder are to be written on the back of such envelope.

The manner, place and time of opening of bids: The public opening of bids will be conducted on the day **01 December 2017** at **12:30** by the Commission for public procurement, in the premises of the Contracting Authority at the address **Kralja Milana 36, Belgrade, I floor, Conference Room.**

Before the opening of bids, the representatives of bidders participating in the public opening are to submit to the Public Procurement Commission a written power of attorney (authorization) issued on the letterhead of the bidder, sealed and signed by an authorized person.

The deadline for making a decision on awarding the contract: Contracting authority shall issue the contract award decision pursuant to Article 108, paragraph 2 of Law on Public Procurement.
